Eligibility Norms

A bachelor's degree of a minimum of three years' duration or its equivalent in any discipline from a recognized university & 50% marks in aggregate is required apart from a valid score in CMAT or CAT or **KMAT-Kerala**. **Candidates completing their final year degree exam latest by June 2019 are also eligible to apply**, provided they secure the requisite percentage of marks. Students aspiring to get admission in DCSMAT MBA programme should qualify in CMAT or CAT or **KMAT-Kerala**. Admission Procedures as per the admission supervisory committee directions. The criterion for selection is 80:10:10, respectively on Qualifying Entrance Test Score, Group Discussion and Personal Interview.

Admission Procedure

The selection process includes scores obtained in aptitude test and the marks scored in Group Discussion and Personal Interview. A student meeting the eligibility criteria has to apply on the **prescribed application form either online or by post/in person at the Admissions Office/Campuses by paying the application fee**. Eligible students will be called for appearing in Group Discussion and Personal Interview which will be conducted by DCSMAT.
